

Prior to joining K2 Intelligence, Jordan served as an Assistant District Attorney at the New York County (Manhattan) District Attorney's office. As a prosecutor, Jordan routinely worked with the Major Case Squad of the New York Police Department on some of Manhattan's most sensitive investigations, involving abduction, extortion, stalking, bank robbery, and art crime, including art fraud, as well as thefts committed within the police headquarters, judicial chambers, cultural institutions, and luxury hotels. One of these investigations resulted in the return of a stolen Salvador Dali watercolor, and the conviction of its thief. Jordan received his J.D. from Vanderbilt Law School and his B.A. from the State University of New York at Albany.




### Raymond W. Kelly

Former Commissioner, New York Police Department


Former New York Police Department (NYPD) Commissioner Ray Kelly brings decades of experience setting strategy to combat threats faced by nations around the world, by the public and by the private sector.
